Discussion

- G.Herman welcomed everyone to the meeting, and questioned if EMS units could logistically swap Robertson and Sumner County response areas in White House and Portland.
- A.Holt stated that he was not opposed to the idea and noted that now is the time to make the transition if it is going to happen, due to the addition of the new Sumner County E911 center.
- K.Douglas mentioned that in Millersville they are in a similar situation but the S.C. Commission turned down the idea because they did not feel that they should pay for services provided to citizens in a different county. However, S.C.E.M.S is open to the idea because of response times.
- A.Holt suggested including Millersville in the EMS response zone discussions,
- All representatives agree that it is a top priority to protect our citizens by providing the best response times possible.

Steps Completed

Discussion

- G.Herman welcomed everyone back together to discuss in further detail the EMS response times and potential zone swaps for Millersville, Portland, and White House.
- After reviewing the call volume information RCEMS and SCEMS both think that the zone swaps could be manageable with current personnel and trucks.
- RCEMS would like to look at the SCEMS transport numbers
- K.Douglas questioned when the time frame is that factory calls in Portland ramp up for the holiday season. He would like to see all call numbers during 2016, and analyze calls between October-January and February-September.
- A.Holt noted that these three cities are continuing to grow and something needs to be updated to improve service to citizens.
- E911 mapping needs to be updated in the three cities to show zones appropriately for the counties that are responding.
- A.Holt does not feel like there is a money issue to take into consideration when making these adjustments. In fact, it might be possible to start the new zones prior to July 1st if all parties agree.
- K.Wilber will work on constructing a resolution for the cities to use to show a unified front in the need for updating response zones.

Next Steps

1. Millersville, Portland, and White House to meet with city councils and discuss the possible EMS response revisions. Portland and White House to hold study sessions in October, and Millersville was going to discuss at tonight's council meeting.

- 2. A.Holt will discuss this topic at the SC E911 meeting, and D.Eden will discuss at the RC E911 meeting.
- 3. D.Eden will have another conversation with Mayor Bradley about the details of this plan.
- 4. White House to schedule a follow-up meeting in two month (end of November) for the group.

Steps Completed

- 1. Millersville, Portland, and White House met with city councils to discuss possible EMS response revisions. Each city passed resolutions showing support of the transition.
- 2. White House to schedule a follow-up meeting for late November.

Discussion

- K.Douglas is still investigating the call volumes in the Portland factory area, but he thinks the call volume looks manageable. There is a possibility of moving a 12 hour truck that is based in Portland to a 24 hour truck to manage the call volume.
- R.Gupton noted that the transition might add 1.5 more calls per day to RCEMS for the White House zone. However, due to the anticipated growth of White House RCEMS has been planning for the growth and the additional calls will be factored into future plans.
- T.Jetton stated that logistically SCECC can make the changes work in their dispatching system. However, nothing will geo-validate across county lines. The reason information will not validate is a state level issue with software. It is impossible for RC to replicate SC in their dispatching systems. This is a factor for all calls that come in via cell phone, which is approximately 85% of the calls.
- H.Petersen mentioned that by transitioning there will be smoother dispatching protocols.
- K.Douglas brought up mutual aid dispatching for the White House area. He asked that SC be dispatched to White House if SC is the closest available unit. All parties agreed that with established policies and training on zone coverage, this could be an option.
- H.Bradley questions if there is a state agency that needs to approve the transition, but he was assured no other agencies had approve alterations to the SC and RC response zone agreement. However, state agencies have been informed that there is discussion of possible changes in our counties.
- A.Holt suggested that the transition take effect on July 1, 2018. However, the E911 groups asked that the effective date be August 1st because it is a work day, and it will

give them time to rearrange ESN for different counties (map changes, response zones) and train the dispatchers.

Next Steps

- 1. The next Sumner County EMS Board meeting will be held the first Monday in December (12/4) at 5:00 pm, in Sumner County Administration Building, room 112. A.Holt asked that all parties to be present to show support of the transition.
- 2. D.Eden to ask that the Robertson County EMS Board recommend moving forward with the transition at tonight's meeting.

- (2) Summer County Emergency Medical Services shall provide emergency medical services and answer calls in the Robertson County city limits of Portland and Millersville; and
- (3) Robertson County Emergency Medical Services shall provide emergency medical services and answer calls in the Summer County city limits of White House; and
- (4) Each County EMS service shall charge the patient seen pursuant to existing county charges for the service which provides the care; and
- (5) No bill or invoice shall be charged to the respective county for any services provided.
